



## HOLY FAMILY & ST. MICHAEL'S CATHOLIC PRIMARY SCHOOL

**The main aim of our Mission Statement is that our teaching and learning are centred on the teaching and example of Jesus Christ.**

### ADMISSION POLICY 2010-11

Holy Family and St. Michael's Catholic Primary School was founded by the Catholic Church to provide education for baptised Catholic children. The school is run by its governing body as part of the Catholic Church in accordance with its Trust Deed and Instrument of Government and seeks at all times to be a witness to Jesus Christ.

If the number of preferences received is less than the admission number then all preferences will be met. However, when there are more applications than places available, priority will always be given to Catholic applicants in accordance with the oversubscription criteria listed below. By applying to this school parents, or carers, are declaring their support for the aims and ethos of the school.

The governing body has responsibility for admissions to this school and intends to admit 15 pupils to Upper Foundation Stage in the school year, which begins in September 2010.

#### **Oversubscription criteria**

***At any time where there are more applications for places than the number of places available, places will be offered in the following order of priority:***

1. Looked after children from Catholic families.
2. Baptised Catholic children who live in the defined area.
3. Other baptised Catholic children.
4. Other looked after children.
5. Children of other Christian denominations, or of other Faiths, whose parents or carers are in sympathy with the aims and ethos of the school and whose application is supported in writing by a minister of religion or an appropriate religious leader.
6. Other children.

Catechumens are to be given priority next after baptised Catholics in each of the above categories.

*Where the offer of places to all the applicants in any of the categories listed above would lead to oversubscription the following terms will be applied.*

The attendance of a brother or sister at the school at the time when the younger child starts school will increase the priority of an application within each category. (see notes)

## **Tie Break**

**Where the offer of places to all the applicants in any of the categories listed above would still lead to oversubscription, the available places will be offered to those living nearest to the school 'As the crow flies' will be used as the measure (see notes).**

## **Application Procedures and Timetable**

Failure to provide a Common Preference Form (CPF) would mean that the application is not valid and failure to provide a Supplementary Information Form (SIF) could mean that the applicant is placed in the last criteria.

Any parent who wishes their child to attend Holy Family and St Michael's may contact the School Secretary to register their interest in applying for a place at the school and to fill in a Supplementary Information Form. This information will be forwarded to the LA. The CPF will be sent out automatically by the Local Authority in the October prior to the academic year in which the child is due to start.

The standard application form, known as the Common Preference Form must be completed and returned to the Local Authority, School Admissions, Room 62, County Hall, Wakefield WF1 2QL by 16<sup>th</sup> November, 2009. The Supplementary Information Form attached to this policy should be submitted by the same date to the school. Parents or carers will be advised of the outcome of their applications on 2<sup>nd</sup> April, 2010. Unsuccessful applicants will be given reasons related to the over-subscription criteria listed above and advised of their right of appeal to an independent appeal panel.

## **Reception Class (Upper Foundation Stage) Admission**

For all children who are due to start school in our Reception class in any academic year, the admission process will be as follows:

Children are admitted to the Reception Class at the beginning of the school year (i.e. September) in which their fifth birthday falls.

Places are offered on either a full-time or a part-time basis (Children aged four are offered two terms part-time education of three full days, Monday, Wednesday and Friday, prior to full-time admission, dependent on the child's date of birth see below):

Pupils will start school in the in-take year (ie full-time Reception Year) based on the following dates:

Born between 1<sup>st</sup> September and 31<sup>st</sup> March – start school on the first day the school is open following the 1<sup>st</sup> September 2010.

Born between 1<sup>st</sup> April and 31<sup>st</sup> August – start school on the first day the school is open following the 1<sup>st</sup> January 2011.

## **Waiting Lists**

As well as their right of appeal, unsuccessful applicants can apply to be placed on a waiting list. This waiting list will follow the order of the oversubscription criteria set out above. Names are normally taken off the list after six months.

## **Appeals**

Parents who intend to make an appeal against the Governing Body's decision to refuse admission must submit a notice of appeal to:

## **Pupils with a Statement of Special Educational Needs**

The admission of pupils with a Statement of Special Educational Needs is dealt with by a completely separate procedure. This procedure is set out in the 1996 Education Act. Details of this separate procedure are set out in the *Special Educational Needs Code of Practice*.

The school will admit children with statements of Special Educational Needs in which Holy Family and St. Michael's Catholic Primary School is named in the statement.

1. Schedule 27 of the 1996 Education Act states that there are only two reasons for an admission authority to refuse admission to a Statemented child.
2. The school is unsuitable to the child's age, ability or aptitude or to his/her special educational need.
3. The attendance of the child at the school would be incompatible with the provision of efficient education for children with whom s/he would be educated or the efficient use of resources.

### **Notes (these notes form part of the over-subscription criteria)**

**Catholic** means a member of a church in communion with the See of Rome. A certificate of baptism in a Catholic church, or a certificate of reception into the full communion of the Catholic Church, will normally evidence this. This includes the Eastern Catholic Churches.

**Catechumens** are those children who have given an explicit desire to be baptised into the Roman Catholic Church and who are currently preparing to receive the same by regular participation in Sunday worship and a recognised programme of preparation. A letter from the Catholic priest preparing the child is required.

**Looked After Child** has the same meaning as in section 22 of the Children Act 1989, and means any child in the care of a local authority or provided with accommodation by them (e.g. children with foster parents).

**Defined area** is a geographical area. Please see boundary maps available for inspection in school (boundaries determined by the Diocese of Leeds).

**Siblings (Brothers and Sister)** includes children with brothers and sister (including step-brothers or sisters residing at the same address) of statutory school age, living at the same address, in attendance at the same school, or a school on the same site, on the date of admission.

**Twins or Triplets** - where a family of twins or triplets request admission and there is only one school place available, it will be left to the family to decide whether or not they wish to take up the place for one of their children, and appeal for the second or third child in the same year group, or to decline the place.

*In all categories, when decisions have to be made between children satisfying the same criterion, children living nearest to the school, measured as the crow flies, have priority. The distance measured will be from the central (centroid) point of the applicant's property to the central (centroid) point of the school's grounds. Measurement will be made using the LAs in-house admission system and mapping software.*

Please note an application to Early Years does not guarantee that your child will automatically be allocated a place in school. All applications will be considered in accordance with the Governors' Admissions Policy.
