BRIEF DESCRIPTION OF APPLICATION: Amendment to existing condition regarding door supervisors to read: “An SIA and Approved Contractor status door supervisor shall be employed at the premises and shall be on duty on Fridays, Saturdays and all Sundays before bank holidays after 21:00hrs up until the premises are closed. A second door supervisor will be working at the premises when the occupancy at the venue reaches 50 persons (customers and staff). These are the minimum requirements and management may deem it necessary to have additional door supervisors as events or circumstances dictate.

Also the addition of the following conditions:

- “In order to ensure compliance with above condition, a written register/log in a bound format will be kept, recording occupancy numbers for Fridays, Saturdays and Sundays before bank holidays. This must be checked and certified as a true record on the listed days by the licence holder or designated premises supervisor. The register shall be made available for inspection by W£est Yorkshire Police or local authority enforcement officers immediately upon request.”
- “At least one working note net/CCTV radio shall be used during trading hours and be on the premises at all times.”
